the Appointment of the Composition of the National Steering Committee on Civil Registration, Vital Statistics, and Identification

- Having seen the Royal Kram No. NS/RKM 0196/08 dated January 24, 1996 on the promulgation of the Law on the Establishment of the Ministry of Interior;
- Having seen the Royal Decree No. NS/RKT 0217/143 dated February 9, 2017 on the Establishment of the National Steering Committee on Civil Registration, Vital Statistics, and Identification;
- Having seen the Sub-Decree No. 109 ANKr.BK dated August 19, 2015 on the Arrangement and the Proceeding of the Ministry of Interior;
- Having seen the Sub-Decree No. 544 ANKr.TT dated May 23, 2017 on the Appointment of the Composition of the National Steering Committee on Civil Registration, Vital Statistics, and Identification;
- Referring to the request of the Minister of Interior;

It is hereby decided to

Article 1.-

Appoint the Composition of the National Steering Committee on Civil Registration, Vital Statistics, and Identification as follows:

1. His Excellency Aphisanthipundit **Sar Sokha** Deputy Prime Minister,
Minister of Interior, Chair;
2. His Excellency **Pao Ham Phan** Secretary of State, Ministry of Interior,
Deputy Chair;
3. His Excellency **Chhieng Yanara** Minister Attached to the Prime Minister,
Secretary General of the Cambodian
Rehabilitation and Development Board of
the Council for the Development of
Cambodia, Member;

Article 2.-

In case any Ministry, institution or unit has changed the above composition, it shall make a request to the National Steering Committee on Civil Registration, Vital Statistics, and Identification for re-appointment.

Article 3.-

Any provisions that are contrary to this sub-decree shall be repealed.

Article 4.-

Minister in charge of the Office of the Council of Ministers, Minister of Interior, Minister of Economy and Finance, Minister of Planning, Minister of Health, Minister of Justice, Minister of Foreign Affairs and International Cooperation, Minister of Posts and Telecommunications, Ministers of all ministries, heads of all relevant institutions, and individuals listed in the Article 1, shall be charged to implement this Sub-Decree as per their defined duties from the date of signing.
